

# FISCAL YEAR 2021 APPROPRIATIONS PRIORITIES





The West's open spaces, forests, rangelands, watersheds and agricultural soils – and the benefits they provide to all Americans – have never been more important or more threatened.

In America's rural West, economic, environmental, and community health should go hand in hand. Federal land management agencies, rural communities and businesses can work together to reduce the risk of uncharacteristic wildfire, improve ecosystem health, strengthen rural economies, and support the rural communities that help steward our public and private lands. With sufficient and stable funding for federal land management agencies, public and private lands conservation programs, and rural development programs, we can foster the health of the American West. Congress must sufficiently invest in federal agencies so they can support both vibrant rural communities and healthy landscapes.

To help rural America, the Rural Voices for Conservation Coalition recommends four funding priorities for 2021.

## **RVCC'S TOP FUNDING PRIORITIES**

- 1 Investments in proactive fire risk reduction to protect rural communities and create rural jobs
- Rural development programs, including Rural Business Development Grants and the Rural Energy for America Program
- Research that informs public lands management, particularly the impacts on rural communities and economies
- Private land stewardship programs that help landowners maintain and restore the health of the land



# FISCAL YEAR 2021 APPROPRIATIONS PRIORITIES



#### FIRE RISK REDUCTION AND PUBLIC LANDS RESTORATION

To be strong partners to local communities, federal land management agencies must receive enough funding to accomplish their missions, including proactive hazardous fuels reduction, management of threatened and endangered species, and fire suppression. RVCC encourages restoring funding to programs that proactively reduce the risk of uncharacteristic wildfire.



#### RURAL DEVELOPMENT THROUGH LAND STEWARDSHIP

RVCC encourages Congress to support programs that contribute to collaborative restoration and stewardship economies on both public and private lands, including the Collaborative Forest Landscape Restoration Program, Farm Bill working lands conservation programs, and the State & Private Forestry Landscape Scale Restoration program.



#### **BUSINESS DEVELOPMENT FOR RURAL ECONOMIES**

Growing economic opportunity is vital to maintaining healthy rural communities. Federal investments in rural infrastructure and business development are critical to help start and expand rural business ventures through programs such as the **Rural Business Development Loans** and the **Rural Energy for America Program**.




#### **SCIENCE SUPPORTS RURAL COMMUNITIES**

Forest Service Forest and Rangeland Research and the Joint Fire Science Program play vital roles in shaping and improving economic and environmental outcomes on the ground. Research focused on responding to the rising threat of uncharacteristically severe wildfire is important, as are efforts focused on innovative wood products, recreation, rural economics, and the social impacts of public lands management. Information on changing rural social conditions and economies, like found in the Northwest Forest Plan socioeconomic monitoring efforts, can inform public lands management decisions and improve understanding of the economic impacts of public lands on rural communities.
